Agreement For Larger than Sample Size Non-Alcoholic Beverages Waiver's

PURPOSE

Las Vegas Convention Center (LVCC)

To provide a document that will be mutually agreed upon by show organizer/show owner, the Las Vegas Convention Center and the exclusive provider of all food and beverage at the center, Sodexo Live!

DEFINITIONS

“show” = show management and lease of the space for the event.

“company” = Sodexo Live! its partners or subcontractors.

“event” = The 2026 NACS Show

“exhibitor” = The company or organization that has purchased a booth or space on the event trade show floor.

“retail” = All locations owned and operated or subcontracted by Sodexo Live!

“product” = Approved items for sampling and give away.

QUALIFICATIONS

This waiver program is only applicable for exhibitors that are the manufacturer, producer, or distributor of the waiver products. Exhibitors must be on the leased show floor of the event. Foyers, hallways, public space, parking lots and meeting rooms not applicable. There will be no exhibitor products in retail locations unless approved in writing by the company.

CONDITIONS

Waiver’s will be provided to pre-approved exhibitors only. Qualifying exhibitors will provide to the company, in writing, number of product cases, pack size (unit amount per case), and unit size (oz/ml). For the purposes of the memo, all product descriptions and cases will be detailed via a Banquet Event Order (BEO), the company will produce for the exhibitor. All BEO’s must be finalized and signed by exhibitor no later than the posted catering order deadline date .

Sampling Company must provide a product manifest to Sodexo Live! to include all sample product being shipped into the property. On property, the company will conduct case counts with each exhibitor and the par count will be signed by the company and the exhibitor. If cases are added or reported during the event, the exhibitor will be charged an additional 25% administration fee.

PRICING - Full Size Samples of Pre-approved Non-Alcoholic Beverages Up To 16oz each- (Does not pertain to Bottled Water) All pricing will be a base fee billed based on received day by exhibitor. Flat fee based on case volume in the following segments.

100 cases = \$2,400 ++ flat fee

200 cases = \$4,800 ++ flat fee

300 cases = \$7,200 ++ flat fee

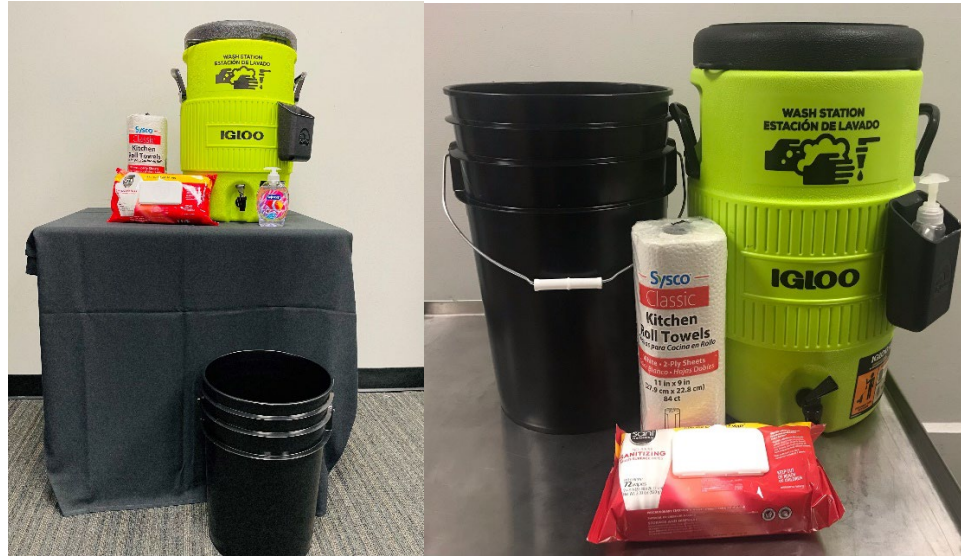
The company will quote other metrics pricing based on each product scenario. ++ is 19% service charge and sales tax. Any changes or add on during the event must be approved by the exhibitor authorized point of contact.

SEE BELOW SNHD INFORMATION

SOUTHERN NEVADA HEALTH DISTRICT (SNHD)

The SNHD will inspect every booth each day of the event. It is imperative that every area, booth, or room where food preparation, food/beverage is demonstrated or sampled that is not completely sealed or not in package form **MUST** have a SNHD sanctioned sanitation hand wash kit. These can be rented from Sodexo Live! on site at \$150+ state tax each.

Guests can provide their own but must meet the SNHD mandate. See photo of approved kit by SNHD.
